- 1. \*\*Meeting Schedule Confirmation:\*\*

- Old chancel furniture: Mark and Ron Prazak to create a design for historical display (funded by Sharon and Dennis Frick, \$500). Motion by Marianne, seconded by Sarah, passed unanimously.

- YTD Income: \$88.6k; Expenses: \$97.1k; Deficit: -\$8.1k. Cash + receivables: \$273.9k; Dedicated funds: \$191.4k.
  - Motion to approve financials by Sarah, seconded by Bennett, passed unanimously.
  - Actions:
  - Kerry to add endowment as a side note, not on balance sheet.
- Kerry to meet with Endowment Committee on loan investment options (fixed or adjustable rates).
- Pr Leland's \$30,000 housing allowance approved unanimously (motion by Marianne, seconded by Deb).
- Moving expenses for Pr Leland: \$15k vs. \$9k approved. Motion for \$3k additional by Kerry, seconded by Kelly, passed with two abstentions. Kerry to review funds & email to the rest of the group.
  - 2025 financial review: Pr Leland to email committee (Mark Groff, Pat Mann, Dan Skrypak).
  - Kerry to create a document tracking committee terms and integrate into Breeze.
- 16. \*\*Personnel Committee (Kerry):\*\*
- Dir of Traditional Music hire in progress. Job descriptions nearly done for next meeting. Employee manual ongoing.
  - Nursery applicant interview on March 31; Susie to seek exec team approval.
- Action: Pr Leland and council to set 1-3-6 month goals using MSP. Kelly to coordinate small groups with call committee for Pr Leland to meet members.
