Call Committee Report – Kell/Stemig

- They are pooling together a list of interview questions and working on paring it down.

Report on Office Manager Position – Pastor Steve

- Tuesday, June 14th Amy Pizzella will start. Staff are working to get her up to speed and oriented.
 - o Her contract will be the same as previous office manager, Amy Minear.

Report on Director of Music Position – Pastor Steve

- Kyung's final Sunday is this week, June 5th. His contract will run through July 3rd. He has music covered until then.
- Discussion on hiring a single person to direct all music or split the position into a choir director and instrumental music director. Also could hire a temporary person to get through the summer.
- Pastor Jen has agreed to help Pastor Steve and the Worship Music and Acts Team to discuss a plan and put together a proposal for the Planning Council at a future date. No formal decisions, or interview teams, are made or available at this time.

Nominating Committee – Pastor Steve

Financial Report – Skrypek

- Still have a net surplus, but that number is starting to dwindle, as predicted. Similar expenses are over budget has highlighted in previous months, as well as similar savings.
- Checking account at \$44,000, which has been consistent from last few months.
- Dan shared a first draft of the 2022-2023 proposed budget and solicited questions from the Planning Council.
